2. CONTRACT PERIOD: The candidate shall be appointed on Contract basis for a period of one year and can further be extended for a period of one year.

3. CONTRACT AMOUNT AND OTHER TRAVELLING EXPENSES: The contract amount shall be fixed as the last pay and allowances drawn by the officer less the initial amount of pension fixed before commutation plus relief etc. Payable thereon or Rs. 25,000/- per month, whichever is lower.
